## Acknowledgement of Fireworks By-Law

I have received a copy of Municipal Fireworks By-Law #56-2016 and any amendments thereto, and understand its contents

### Note: Sale of Consumer Fireworks

#### 2.1 No Person shall:

- a. Sell any Fireworks without a Licence issued by the Municipality to do so, pursuant to this By-law. The holder of a Licence issued under the provisions of this By-law shall prominently display the License in the place of business where the Fireworks are being offered for sale and such Licence shall be produced to any Enforcement Officer upon request.
- b. Sell any Consumer Fireworks to any Person under the age of eighteen (18) years.
- c. Sell any Consumer Fireworks during a Fire Ban.
- d. Sell any Consumer Fireworks to any Person except on:
  - I. the ten (10) days immediately preceding the day fixed by proclamation of the Governor-General for the observance of Victoria Day (hereinafter called "Victoria Day");
  - II. Victoria Day;
  - III. the period between Victoria Day and Canada Day;
  - IV. Canada Day and the three days immediately preceding and following Canada Day;
  - V. the ten (10) days immediately preceding New Year's Day;
  - VI. New Year's Day; and
  - VII. Such other day as is proclaimed by the Council for the Municipality as suitable for celebration with Fireworks.
  - VIII. 10 days immediately preceding Diwali
- e. Sell any Prohibited Fireworks.
- f. Sell any Consumer Fireworks in a building unless the provisions of the Ontario Fire Code, the Explosives Act of Canada, this By-law and all other Acts and Regulations have been complied with.
- g. Offer for sale, cause to be sold, or sell Firecrackers.

2.2 All Persons thereof carrying on business in the Municipality who propose to sell Consumer Fireworks of any kind or description shall observe the following:

- a. No display of any such Consumer Fireworks shall be exhibited in any display window. This prohibition shall not apply to prevent imitations of such Consumer Fireworks being displayed, provided there are no explosives or chemicals contained in such imitations.
- b. Customers are not permitted to handle any Fireworks that are not in approved packaging until the Fireworks have been
- c. The person must display those Fireworks that are for sale in accordance with the provisions of the Explosives Act
